• Support Multi-stakeholder Dialogues at Country, Regional and Global Levels on Improving Decision-making on Dams and their alternatives with the Aim of Engaging all Stakeholders, with the Emphasis on Governments

 Produce Non-prescreptive Tools Drawing on all Relevant Bodies of Criteria and Guidelines for Planning and Management of Dams and their Alternatives, which Can Help Decision-makers



SOME DDP OPERATING PRINCIPLES

- Contributing to the Flow of information and Experiences and Relevant Practices Around the world
- Knowledge Driven and Drawing from the WCD process, the DDP Process and other Relevant Materials and Examples
 - Focusing on Decision-makers particularly those in Government while Addressing other Stakeholders

- Advocating Inclusiveness of all Perspectives and Consensus over Conflict
- Promoting Wide Consultation and a Partnership Approach
- Remaining Factual and Avoiding being Judgemental
- Evolved over Time

MULTISTAKEHOLDER DIALOGUES (NATIONAL) IN PHASES 1 AND 2

- DDP has been Consulted and/or Supported National Dialogs in More than 20 Countries
- In Phase 1, Supported 7 National/Regional Processes
- In Phase 2, Supported Dialogs in Ghana, Nigeria, Togo and Uganda
- Follow-up and concluding activities in Nepal, South Africa and Sweden
- Not Involved in National Dialogs in Large Dam-Building/Operating Countries such as Brazil, China, India, Russia and Turkey

LINKAGES WITH ONGOING MULTISTAKEHOLDER PROCESSES

The Hydro Sustainability Assessment Protocol (HSAP) – a Tool that is Being **Developed to Measure and Guide** Performance in the Hydropower sector The draft HSAP is Currently Undergoing a Worldwide Consultation and Trialing. - Among the Consultations will be a Meeting on October 30 with the Ghana Dams Forum, which was Set up with the Help of the DDP

WHAT ARE THE POTENTIAL AND CONDITIONS FOR SUCCESS FOR THIS KIND OF DIALOG?

 The potential is great because it can lead to improved outcomes and a greater level of their acceptance by all the stakeholders.

 Greatest impact can be at national and Regional Levels

- Ab initio, the question being addressed has a reasonable chance of a positive outcome
- Widening the menu of options/solutions
- Representation and leadership
- Extensive consultation on developing a broad consensus on recommendations

WHAT WAS THE SUCCESS OF THE DDP IN CONVINCING GOVERNMENTS TO PARTICIPATE IN A MULTISTAKEHOLDER DIALOG?

Substantial

CLOSING REMARKS

The general sense from discussions and views of most of the stakeholders is that DDP helped move the dialogue forward. It departed from the polarization that resulted from the launching of the WCD Final Report and reached a more constructive stance where all different approaches on how to address the development of water and energy resources, - large and small; - centralized and decentralized, - rural and urban, to assist the poor and create development opportunities are accepted as valid and even complementary, options. They need to be included into a comprehensive assessment that takes into account technical, economic, financial, environmental and social issues on an equal standing.
