Africa Toward 2030: Exploring the Future

How could Africa change in the next twenty years? What are the most important forces that underlie possible changes in one direction or another? What seems certain and what seems uncertain about the future of the African continent? These broad questions guide a research project coordinated by the German Development Institute that seeks to explore how the development landscape could change toward 2030 and aims to contribute to debates on how development policy can be adapted to confront changing global circumstances. The purpose of this workshop is to obtain critical feedback and creative input for a book project focusing on possible futures for African development. This book project includes analyses of individual drivers of change (demography, climate change, technological change, new actors in international development, internal political transformation, and global governance processes) and their potential impact on African development in the long-term as well as scenarios for the future that build on these studies.

The focus of the workshop will be on improving the scenarios for the future of Africa, which will be presented as sketches. After a brief elaboration of the main components of three distinct scenarios for the future, participants will be asked to discuss how plausible the clusters of developments described are, whether there are already important signals that indicate the prospects of these scenarios materializing, and how elements of the overall storylines can be refined to better take into account the interrelationships between central driving forces as well as emerging developments across the African continent. Throughout the sessions, participants will be asked to identify potential discontinuities that could disrupt the general scenario storylines and to probe the validity of the assumptions underlying the scenarios.
